General Business

1) Bank Holiday Event

- Run sheet to be the same as 2015 event.
- Cost up \$10 to \$120.
- Richard Mair to send out invites by 8/6/16. Offer from matt Hill to assist is acknowledged.

Sponsorship

- Action item Michael Parker to liase with Gateway CU re sponsorship.
- In regard to TGT sponsorship, discussion held around value of having 1 single major prize this year. Alternate suggestion is to have a number of smaller prizes.
- George Emerson asked is the sponsorship of TGT "net +ve" after taking into account raffle revenue, costs to club etc.
- Steve Chan expressed view that TGT have an expectation of 10 paying customers from sponsorship which to date has not been achieved.
- Stephen McCammond made point that major TGT trip coincided with Elliott this year.
- Profit of Bank Holiday event last year was approx. \$1,500 with over 100 players although committee is mindful that these numbers may not be repeated.
- Rowena Rees-Poole made point that it was not the raffle that determined numbers on the day rather it was the venue.

- Craig Horley suggested that we give TGT access to more clients by diluting prizes across 4 or 5 people via discount vouchers of \$250 per person.
