5. General Business

a. Review/Update/Confirm budgets for 2018

A comprehensive review of the event schedule, subsidies and costs was completed by the committee. Updates and points noted are:

- ❖ <u>Club Game prizes</u> current add on to green fees sufficient to cover prize costs. The range of prizes are generous in comparison to other clubs (social and official) and we will continue with Golf Balls, Vouchers and Wines. A premium sleeve of balls, as against the wine prize, will be trialed this year for those that would prefer this option. So the winner will have a choice and depending on uptake we may choose to alter the mix of wines vs premium balls.
- ❖ The Summer Cup Decided to move to a stroke competition in line with the Winter Cup. S Chan to donate a perpetual trophy for the event which commences in 2018. All other prizes as per normal club games.. There are no subsidies for this event from the club.
- * RS Elloitt Club provides a subsidy for team members of a third of the hosting state costs. The treasurer estimates that for 2018 in Adelaide this will be \$2,500 (inclusive of shirt). Other players (groupies) will receive the traditional subsidy of 10% of hosting club costs, which have been estimated @ \$350 (\$70x5). This brings our subsidy for 2018 to \$3k (rounded and approximate).
- ❖ Interbank Subsidy will remain as previous years \$50 per player capped to a total of \$1,000. As is our ongoing process, preference will be given to non RS Elliott team members ensuring all the club members have the opportunity to share in representative games. However in 2018 we do not have the numbers and may open up the last places to RS Elliott players that can attend. It is important we present a full team to ensure the event is supported.
- ❖ <u>Bank Holiday</u> No subsidy. This is our major fund raising event.
- ❖ Winter Cup Stoke event and no subsidy
- ❖ Coffs Harbour weekend Decision on subsidy deferred to post Bank Holiday to determine if we can provide same support as in previous years. Poor result on bank holiday may see subsidy removed or a different form of subsidy introduced i.e. pizza/dinner for one night considered. Budget has been \$50 per player up to a total of \$1,000 in the past. However 2017 expense was \$640 due to numbers attending. This has been determined as the least important event to attract subsidy, and would be in line for reduction if club strikes cash flow issues for the year.
- ❖ <u>Westpac Challenge</u> the normal 'grudge match'. Subsidy remains consistent with previous years. 20 players @ \$25 to a total of \$500.
- Presidents Trophy No change to previous year. President sponsors the event.
- Championships No change to previous year. Club provides trophy's with normal club daily prizes.
- Pro Pin Event suggested by RM. An all in cash winner if within 1 metre of the flag. Will trial on a low cost game to see membership take up of the challenge and contribute additionally to Captain's Cash.

- c. <u>Membership –</u> Enquiry was withdrawn, however committee reviewed the current policy of only allowing members either CBA, ex CBA or referred by existing members. This in future will be relaxed for situations like this, however the new member must play as a visitor for a few games to establish handicap and ensure both the player and club fit well together. It was noted the outstanding action item in the minutes was established in 2017 to try to attract new members and keep the club viable, so we are already progressing down this path.
- d. Coffs Harbour 24th/25th Nov New Agenda item added during meeting Bonville has requested a 20% deposit for the game. Negotiation is ongoing and we hope to reduce that commitment. Will rely on QLD to share their risk/cost as well. The event has been running since 1984 (best knowledge of SmC) and we have been attending Bonville for over 20 years. Situation has arisen as other social clubs have booked and not shown up costing the club green fees, and we bear the fruit of other nonaffiliated clubs bad behavior. CBA (NSW/QLD) have never defaulted and attended as booked.
