1. Welcome - 06:00 PM - C Horley

With 4 games to go in 2020, with an estimate of \$400 Captain Cash return, the EOY final estimate is \$1000 profit approx., taking into account Coffs subsidy (1750) and trophies (450) costs.



b. Recent Games Wrap up

Bank Holiday

A successful event with scaled down numbers to 63 players due to the Covid situation. Financially we achieved a good result, partly by trimming down the raffle prizes due to numbers.

2021 to consider a new venue, as the committee did agree a regular change does increase attendance numbers and we need to keep the event 'fresh'.

RM commented the event was managed well by the people who put in the effort this year, with special mention to TH and his spreadsheet which allows final score and results to be quickly collated and documented.

Winter Cup (2020 + Peter Bendeich proposal)

2020 Cup was initially in jeopardy due to Federal cancelling the booking due to Covid restrictions, but follow up alleviated their concerns and we were allowed to hold the event as we have in the past.

The two days experienced very different conditions but consensus was another good weekend away.

Glen Williamson was successful, winning the event at Federal Course.

David McCann sent a thank you to the Course General Manager for their hospitality and has been documented in these minutes in Correspondence section.

Our Patron and sponsor of the event has tabled a proposal for future Winter Cups and the committee is in agreement with his thoughts on refreshing location and perhaps time. The committee will wait on his final proposal for 2021. CJH to respond to Peter that this was well accepted and we will await further details.

CBA/Westpac Challenge

Hosted by CBA and was a closely contested event again at Riverside Oaks Bungool course, with the results ending up at 10 games each, with the deciding factor going down to overall team stableford points scored.

Westpac won the day, just topping CBA by 1 stableford point - 523 to 522.

The Challenge has been booked for 2021 again at Riverside Oaks, but this time we will play the original GANGURRU course.

c. Elliott 2021 – Latest Update

Due to Covid-19, the RS Elliott event for 2021 has been **cancelled** for that year only. RM is suggesting postponement till spring but in reality will be a recommencement in 2022. Other states have not shown a great deal of interest in 2021 at this stage.

An alternative suggestion for each state to run their own competitions at the same time and compare the results to find a 2021 winner was not viable due to interest levels and then course ratings not being identical.

A review of the 2022 host state will be held during 2021. Potentially still WA, just put back a year.

d. Long Reef - cost vs viability/alternative

Small number of membership responses to David McCann email is that they still wish to play Long Reef GC despite the increase in cost. It has always been one of the expensive courses on our calendar.

Various suggestions were discussed, such as club sponsoring Captain Cash (GW) for this event was discussed and eventually discarded.

RM comments that perhaps we might negotiate a better deal given our numbers, years playing at the course and the associated food and beverage resulting. Committee members generally agreed this was unlikely to provide any financial relief.

Direction was given to place an item on the AGM agenda to discuss costs per game and receive feedback from the members. Our two most expensive courses are Long Reef and Mona Vale.

e. Slow Play (Strathfield) (consequences!)

Warren Francis raised the recent game at Strathfield GC, where some of our later groups received criticism from members as they had to wait for our groups to play through to our second nine. We need to ensure our speed of play does not drop during the round and between groups.

RM has commented we need fixed rules with consequences or nothing will change. It was suggested to have a committee member in each group, or more mention at games, perhaps points reduction if finishing more than 10 minutes behind the previous group or other penalties.

A contentious issue and President and Captain to discuss further as we have addressed previously and topic is regularly raised during the year.

f. Regional Covid Restrictions

Glen Williamson raised concern over the current Covid situation with restrictions on sport in 'non-home' locations. Would it affect the Coffs weekend?.

George Emerson is currently aware of the situation, especially as other games have been scheduled for that trip. He is keeping close eye on developments and will advise those affected if something changes.

At this stage both Coffs Harbour and Bonville have not issued any changes to their playing regulations at this stage.

g. 2021 Committee – Booking Office – Bendeich proposal.

RM has commented we need a committee to run successfully and concerned at the negativity in some circles about certain roles.

Without a committee we do not exist as a club.

The meeting discussed the election of 2021 committee and directed all committee to seek interest from the wider membership for office bearer positions, especially the longer term members who's situations may have changed and find more time on their hands.

- G Williamson suggested that there are different ways we can arrange future events e.g.; 1) Offer a package deal, 2) NSW only arrange golf component with accommodation etc. the responsibility of individuals.

RM has prepared a draft proposal which will be circulated for comment then presentation at delegates meeting.

Points from discussion follow:

- 2021 will keep the rotation around states continuing with WA scheduled for the event.
- CBA will drive but develop the event in a way such that Sydney is not at financial risk.
- The sub committee with develop the plan to have states contribute upfront.
- 2020 Delegates discussed and the general consensus was reached
 - Main competitions will become handicap driven to encourage everyone to contribute to the team score.
 - S.Cooper correspondence was considered that requested a scratch event continue to promote the tradition of the event.
 - S Chan accepted there is potential for a new scratch trophy but perhaps not the Melbourne Cup Trophy. There were only 3 real scratch contenders in 2020 out of 46 starters.
 - GE stated the day may have arrived to move stableford/net over the main scratch event because it could result in team makeup skewing towards low handicappers in lieu of other club members who may deserve a spot.
 - General view that all team events must be stableford (see point 1 above).
 - There is a possibility that some teams in the future may not be state based if states cannot field full membership.
 - o RM to send out his proposal for the future events to the committee. FEEDBACK REQUIRED. GW will collate.
 - o RM, SC and GW to form a small committee to fashion the proposal going forward.

DMcC called for a mandate for a selection criteria to be defined and agreed in committee, then placed before the members at AGM for ratification. GE commented that the key factor here is member ship transparency, where all know and understand the selection criteria. RM agreed with DMcC call for mandate. Selection committee is a thankless role and it can be seen as gray areas across the selection process. He did caution on whatever is defined, that we remember we are a social club and representation must be achievable for all members regardless of skill or attendance record. SC defined the pervious criteria was 'generally' top 5 Presidents Trophy finishers with the rest of the team more discretionary after discussion. Previously there has been a push to balance across grades, however as the tournament is heading more towards handicap basis, that may make the selections a little easier. It has never been purely on years playing attendance and taken into account service to the club as well. General comments – we have a group of core players throughout the year but that does not and will not guarantee selection as a representative of the club. Any change in selection criteria, regardless of a change or making more transparent, must be ratified as a motion at the AGM. This will require definition, agreement by committee and then circulation to the members prior to AGM. Proxy membership votes will be able to be provided to the Secretary who will table the numbers at the AGM to ensure everyone who has an opinion gets a vote in the direction. Suggestion for the selection criteria to be sent to the secretary who will collate and make available to the committee to discuss and decide, prior to ratification for release to membership. CH Comment - No date was agreed for feedback but end of
