MINUTES

1. Welcome - 06:30 PM - R Mair

RM offered a warm welcome to all attendees (in person and on the phone).

Has been a quiet period since last meeting with nothing of importance to advise from President perspective. Expectation is this meeting will focus more on Bank Holiday updates and actions.

2. Acceptance of Meeting 05/05/2022 Minutes - C Horley

Previous minutes uploaded to Web site and accepted as accurate.

Accepted - Dave McCann Seconded - Stephen McCammond (LM)

3. Treasurers Report - G Emerson

Accounts positive with not all income from bank holiday (mastercard transactions) logged. Expenditure for bank holiday also to be updated with GE expectation as break even at the end of the year based on current projections.

GE raised a question on shirts for new members. There are a few 'owing' as joining fees have been collected. RM has issued approximately 10 shirts and waiting on new members to attend a game for shirt size determination. He raises at all games that he has shirts available and will continue to do so.

Bank Holiday has been locked in, but no deposit has been paid – SC will follow up with Macquarie Lakes to ensure we are ok to pay on the day.

SMcC raised the \$10 O/S entry on the Treasurers report, which was advised as confusion on a recent payment by SC and is being rectified.

Financial details as presented by the treasurer reviewed and accepted by the meeting.

b) Bank Holiday Update

- RudiM advised as at this meeting we have 68 players registered (31 members & 37 visitors). Meeting noted that several members in attendance are still to submit their form. Club is hoping for a field of 80 minimum.
- SC will cross check registrations for the event on Golf Pad, the paper book used at each game against RudiM responses to ensure none have been missed. We have three streams of nomination in 2022.
- Cards will be written up without the handicaps added (see next point).
- SMcC will review all handicaps on Sunday 31st July for latest changes. Final handicaps will be provided to the starters on the day for addition to the scorecards and ensure Golf Pad is accurate. SC will review and follow up on the morning at the course.
- SMcC will individually process the current 4 non golf link players.
- Event will use Golf Pad for score/results on the day, however events such as Veterans and multiple winners on events to be manually calculated.
- SC will determine the events (NP, LD, D&P, D&P (V) and provide markers.
 Committee to be updated via email prior to the event.
- Grades to be determined via GolfPad on the day.
- Gateway Bank have again offered to donate Umbrellas, Balls and Trophy for the event.
- Starters for the day will be David McCann, Stephen McCammond and Simon Soo (TBC).
- Scoring over sight by Richard Mair and Steven Chan.
- Raffle sellers on the day will be sourced from club members.
- RudiM raffle update 175 tickets sold (predominately \$20 donations) with \$370 to date received.

c) Presidents Cup - points clarification.

- SMcC raised the issue that the change to the Presidents Trophy points in 2021, due to smaller member numbers, may be disadvantaging some new members with our larger fields we now enjoy regularly.
- The 2021 change revised the points for a win to 30 (max) and adjusted downwards through the field based on results.
- SMcC has been, for 2022 events, increasing the 30 (max) to the size of the field and allocating 4 points for attendance, mainly because some new members attending games to achieve handicaps would be unfairly treated at the end of the year as a result.
- This discrepancy was raised by a current member to SMcC, who then realized we are in contradiction to last years change to rules (documented on the club web site).
- The committee discussed the issue and agreed to continue with the process SMcC is using, which is at odds with the 2021 decision, documented on the web site. The minimum will still be 30, but the maximum will reflect the field size on the day. For fields greater than 30, 4 points will be the minimum allocated across the field on the day for those at the end of the results calculations.
- An action for the 2023 committee to review process has been raised.

d) Coffs Harbour Update

- Has been booked for November 2022
- Game at Bonnville on Sunday or Monday only unless staying at the resort.
- GE reviewing courses on way up the coast and will advise accordingly i.e Gunnadah and Tamworth (x2).
- QLD will attend and be hosting in 2022

e) Elliott 2023

- SC is investigating if other states have interest in the 2023 event.
- GE proposed CBA (as the organizers) decide on the destination and send out the invitation to the other states.
- SMcC concerned other states may think we are 'taking over', but majority of committee believe this will not be the case. In previous discussions with the states it was agreed that NSW, as the strongest club, would be the driving force and advise the other states accordingly. Expectation WA will be interested, and we may receive a few acceptances from other states, but not enough to field individual teams.
- GE suggested we should investigate package deals and seek assistance in running the event.
